**RESOLUTION NO. 2019-19**

**REIMBURSEMENT FOR THE DISCONTINUATION OF THE FIRST RESPONDERS UNIT; WITHIN THE CITY OF INDEPENDENCE, BUCHANAN COUNTY, IOWA.**

**WHEREAS**, the City Council of the City of Independence met in regular session on Monday, March 25, 2019 and by majority vote approved and authorized reimbursement for first responders as outlined below; and

**WHEREAS**, in 2017 the City entered into contractual agreements for the reimbursement of Emergency Medical Technician (EMT) course totaling \$1,850.00 with costs laid out as:

**WHEREAS**, the City Council moved to discontinue this service on March, 11, 2019; and

**WHEREAS**, the employees whom have successfully completed this course work in full and have also paid their reimbursement agreement in full, shall be reimbursed in the amount of nine hundred and twenty-five dollars (\$925.00) as a result of the discontinuation of the service; and

**WHEREAS**, employees whom have successfully completed this course work in full and have not yet paid their reimbursement agreement in full, shall have the deductions from their checks terminated and they shall be reimbursed the amount in which they had paid; and

**WHEREAS**, the employees whom had not successfully fulfilled the requirements of this course work must begin to reimburse the City for the addition nine hundred and twenty-five dollars (\$925.00) to compensate the City in full for the EMT Course as outlined in their original reimbursement agreement.

**THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF INDEPENDENCE, IOWA** met in City Hall Council Chambers on January 14, 2019 at 6:30 p.m. and by majority vote approved and authorized the outline reimbursement for the first responders.


