

RESOLUTION NO. 2021-66

APPROVING SALARY INCREASES FOR THE SALARIED AND NON-BARGAINING EMPLOYEES TO BE EFFECTIVE JULY 1, 2021; WITHIN THE CITY OF INDEPENDENCE, BUCHANAN COUNTY, IOWA.

WHEREAS, the City Council of the City of Independence met in regular session on Monday, June 14, 2021 and by majority vote authorized and approved cost of living increases for the salaried and non-bargaining employees to be effective July 1, 2021; and

WHEREAS, these increases identified below exclude longevity pay:

WHEREAS, the Council has authorized all non-salary, non-bargaining, full-time hourly employees, and part-time Fire Department Drivers with a satisfactory performance evaluation a 2.5% cost of living increase to their current hourly rate; and

WHEREAS, the Council has authorized the City Clerk/Treasurer or her designee to allot said increases to respective personnel; and

WHEREAS, the Library Board of Trustees sets and determines the amounts for Library Staff at a Library Board Meeting; and

WHEREAS, Bargaining Unit Employee amounts have been set by contract as approved by the City Council.

BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF INDEPENDENCE, BUCHANAN COUNTY, IOWA, that the Council met on Monday, June 14th, 2021 at 6:30 p.m. in City Hall and by majority vote approved a Resolution authorizing and approving cost of living increases for the salaried and non-bargaining employees to be effective July 1, 2021; within the City of Independence, Buchanan County, Iowa.


