## APPLICATION FOR EXEMPTION (§ 69.22 SNOW EMERGENCY PARKING ORDINANCE)

City Code § 69.22 Snow Emergency: "No person shall park, abandon or leave unattended any vehicle on any public street, alley, or Cityowned or leased off-street parking area during any snow emergency proclaimed by the Mayor unless the snow has been removed or plowed from said street, alley or parking area and the snow has ceased to fall."

Exemption Requirements: For those properties where there is no driveway or no cutout or curb cut the residents of such properties will be allowed a maximum of two (2) vehicles to be parked on the street during a snow emergency. In order to qualify for this exemption, the resident must contact the Independence Police Department and provide vehicle information to include make, model, and license plate number for both vehicles to be covered by the exemption. The resident will sign a liability waiver and be issued a permit for parking on the street immediately in front of their residence for a period of 24 hours or until snow is removed from the street at which time the vehicle must be moved to allow for street crews to complete snow removal efforts. All vehicles must be registered with the Police Department and have a permit in advance of a snow emergency to qualify for this exception.
